ACCOUNT,

&c. &c.

THE GOVERNORS of St. George's Hospital think themselves obliged, in justice to their Subscribers and Benefactors, to publish an Abstract of their Accounts to the thirty-first day of December last, inclusive; together with a short State of their Proceedings, that the Public may know the application of their bounty, and its extensive benefits, which comprise almost every species of Christian charity.

This undertaking was set on foot soon after Michaelmas, 1733, by some Gentlemen who were before concerned in a charity of the like kind, in the lower part of Westminster. They judged this house convenient for their purpose, on account of its air, situation, and nearness to town; procured a lease of it, and opened a subscription for carrying on the charity here. The subscriptions increased so fast, that on the nineteenth of October they were formed into a regular society, and actually began to receive patients on the first of January following.

How visibly the blessing of God has supported this design appears from the subsequent account of persons relieved—two hundred persons are accommodated within the walls of the Hospital.

Many, doubtless, would embrace the means of promoting so charitable an institution, were they rightly informed of

the purpose of it, and how it is here carried into execution, which the Governors thereof take this public opportunity to mention.

It is to supply those who ought to be the chief care of the public, the honest and laborious poor, with advice, medicine, and every necessary of cure, when so miserably sunk in health that they can be no longer serviceable to the public, nor obtain relief at home: and this without any expense to themselves or families, and very little to the charitable contributor. A slight attention will discover how imperfectly such a purpose must be accomplished by any other method. Direct benefactions of money to the poor sick and lame (unless so large as to take them quite out of the rank of the poor) will fall short of the common charge of medicine and attendance. If the many generous professors of physic and surgery should add their gratuitous assistance, yet can it be supposed their warmest benevolence could ever extend itself to any great number of objects at their several homes? and even if this could be done in and about these two great cities, how few of the industrious poor have a home fit for the bed of sickness, however provided with the few necessaries of life when in health and vigour? In yet better conditions, if the family of the sick person is to bear the burden of supporting him, when restrained at the same time from those labours which should furnish that very support, by their constant attendance on him, the dissipation of their little stock, and possibly a load of accruing debts; will greatly diminish the comfort even of his recovery.

But his admission into an hospital removes at once all this misery and embarrassment; and if we farther take into account the advantage of immediate consultation in all

difficult cases; the certainty of not only good but proper diet; of medicines both good in their kind, and regularly administered; clean and constant attendance, and that by persons versed in it, and of approved diligence and tenderness; it will surely appear that the poorest have, by this method of charity, all the assistance towards recovery, which even those in the higher situations of life could reasonably wish for.

Prayers are daily read to the patients. A sermon is preached every Sunday; the communion is administered every month, and the Chaplain attends constantly to catechise, and to perform other religious offices; and the patients are supplied with Bibles and Religious Tracts during their residence in the House.

Such are the excellent effects which it has pleased God's infinite goodness to produce by the voluntary subscriptions, benefactions, and legacies to this charity. The number of proper objects is amply sufficient to employ the bounty of the rich, on which the support of this Hospital, under God, chiefly depends. Yet it is thought proper to mention, that small sums from persons of less abilities are acceptable.

To these purposes are admitted as many poor sick and lame, (recommended according to the rules following) as the Hospital will contain, who are supplied with advice, medicine, diet, washing, lodging, and some of the poorest among them with clothes also. The Physicians visit their patients on Mondays and Fridays, and on intermediate days when occasion requires; and the Surgeons every day. No security for the burial of the patients is required, nor any money, gift, or reward taken from them or their friends, on

any account whatsoever. Those who die, if their friends are unable, are buried at the charge of the society. And the money collected in the poor's box at the door is bestowed in small sums among those whose distance from their habitations, or other particular necessities require it.

The visiting Apothecaries are appointed to see that the Apothecary of the house takes due care of the medicines and utensils of the shop.

A Board of Governors meet every Wednesday morning to do the current business of the Hospital, to receive and examine the report of the Visitors, to discharge and admit patients, to receive the complaints and proposals of all persons, and to prepare such matters as are proper for the consideration of General Boards. A General Board of the Governors meets regularly five times a year: and any five Governors, on extraordinary affairs, may require the Weekly Board to summon a Special General Board, on fifteen days' notice, the business of which, and of all General Boards, is then to be specified, and the minutes thereof hung up in the Board Room till the meeting of such General Board.

Every Governor may vote at each of these Boards, unless any claim of his be under consideration, and then he is not to be present. In case any difference arises at these Boards, the question is fairly stated, and determined by ballot, if required. The Governors are in number about five hundred. No person receiving salary, fee, or reward, from the Hospital, is capable of being a Governor: but every other gentleman subscribing five guineas a year or upwards, or giving one benefaction of fifty pounds (although he be not an annual subscriber) is hereupon put in nomination to be

a Governor; and at the first General Court that is held one lunar month afterwards, is accordingly ballotted for by the Governors.

We hope it will appear that the great ends of this undertaking have hitherto been satisfactorily attained, and that they will continue so to do from the nature of our constitution: the number and condition of the Governors furnishing an argument of great probability, that the contributions will not be misapplied.

None are trusted with the care of the patients, either in physic or surgery, or in any other matter of importance, but those who are first elected by the General Board, and these are always answerable to the same for their conduct.

All by-laws are made and confirmed by General Boards: The accompts are passed in the same manner; and, together with the state of the proceedings, submitted once a year to the judgment of the public. These accompts are kept, and together with the acts of every Board and Committee, are faithfully recorded by the Treasurers and Secretary, and a register is kept of all the patients. The Treasurers, Physicians, Surgeons, and visiting Apothecaries, are all Governors, and add to their contributions the most important charity of their gratuitous good offices in their respective stations.

The contributors are requested to send their subscriptions to the Treasurer, at the Weekly Board, held every Wednesday morning in the Hospital: and in order to supply the current expense of the charity, the subscribers are requested to continue to pay their yearly subscriptions in advance.

All persons disposed to encourage this charity, are re-

requested to send their subscriptions or benefactions, with their names and places of abode, if they think proper: and as every Governor has a right to act at all Boards, and enquire into all the affairs of the Society, they are hereby earnestly entreated to make frequent use of this power, especially by attending at the Weekly Boards; and they may be assured, that such attendance will be deemed a considerable addition to their charity, and a very great service to the Hospital.

To prevent uncertainty and confusion in the estimate of our revenue and accounts, it was ordered by a General Board, that circular letters should be carried or sent by an officer of the Society, to give notice to those whose subscriptions are in arrear; which it is hoped no subscriber can take amiss, inasmuch as the consent of every one of them, to be thus reminded, is included in the act of their representatives, the General Board, who made this order.

Such as choose to be benefactors by their last will, have the following form of a legacy recommended to them:

Item.—I give and bequeath unto A. B. and C. D. the sum of upon trust, and to the intent that they or one of them do pay the same to the Treasurer or Treasurers, for the time being, of a Society who now call themselves the Governors of St. George's Hospital, near Hyde Park Corner, which said sum of I will and desire may be paid out of my personal estate, and applied towards carrying on the charitable design of the said Society.

N.B. The variation of this form of Legacy from that formerly printed is made necessary on account of some unhappy mistakes in wills, by which several considerable legacies have been lost to the Society, and the good intentions of the testators have been entirely defeated, because the

sums bequeathed to the Society have been ordered to be raised by sale, or paid out of lands or real estates, which is not now permitted by law.

And by a decision in the COURT OF CHANCERY it has been decreed, that money lent on mortgage cannot be bequeathed to a charity, by which this hospital and other hospitals have occasionally suffered considerable loss.

All Contributors are desired to take Notice,

1. THAT no person is to be admitted a patient (except in cases of accident) without a note from a Governor or Contributor, specifying the name and place of abode of such patient, and that he or she is a proper object of this Charity. And on account of the number of Contributors, each Governor can have but *one* In-patient at a time. Subscribers of *three* guineas are allowed to recommend *three* In-patients every year; and no Governor can have more than *two* Out-patients on the books at one time.

2. That all recommendations are to be delivered every Wednesday morning by ten of the clock; and none will be received after eleven.

3. That in case any out-patient shall neglect coming for two weeks successively, on the day and hour they are ordered to attend, such out-patient shall be discharged for irregularity, except they have had leave from their physician or surgeon.

4. That no patient discharged for irregularity is to be ever again admitted in the Hospital, upon any recommendation whatsoever.

5. That no patient is to be suffered to go out of the Hospital without leave in writing.

6. That no governor, officer, or servant, must at any time presume (upon pain of expulsion) to take of any tradesman, patient, or other person, any fee, reward, or gratification, of any kind directly, or indirectly, for any service done, or to be done, on account of this Hospital.

7. And that, when there is not room for the patients recommended at one time to be received into the Hospital, those are taken in whose admission the Board are of opinion will most effectually answer the end of the charity; and the rest, if proper objects, are made out-patients till there is room for them in the Hospital.

N.B. That most consumptive and asthmatic cases are more capable of relief as out-patients than as in-patients.

At a Quarterly General Court, 10th January, 1817, it was resolved, That all persons labouring under diseases of the eye, shall, in future, have all the benefit of out-patients of this charity, without being required to bring a Governor's letter of recommendation.—The hours for such persons to attend at the Hospital are, from eleven to twelve in the forenoon, every Tuesday, Thursday, and Saturday.

A General Caution to Governors.

It having been ascertained that Letters of Recommendation for this and other Hospitals have been continually obtained under false pretences, and afterwards sold at a regular price, it is strongly recommended to Governors to make every enquiry in their power into the cases of such as apply to them for tickets, in order to prevent themselves from being imposed upon in like manner in future.
